## **RE-ACCREDITATION/RENEWAL OF LEARNING PROGRAMME APPROVAL**

Accreditation or Learning Programme Approval must be renewed every three years. The Accreditation Application Form or Learning Programme Approval Application Form must be completed and submitted with the required supporting documentation (by the relevant submission deadline). Upon receipt of the above as well as a VAT Registration Number, applicants will be invoiced at the same fee as for Accreditation/Learning Programme Approval. (See the table on page 1).

5-15 unit standards	R 300-00 per selected PoE
16+ unit standards	R 400-00 per selected PoE
